On Tuesday, April 18<sup>th</sup>, 2023, members of the Johnson County Sheriff's Office, Franklin Police Department and the Edinburgh Police Department initiated a three day "Child Solicitation" investigation.

This detail or investigation was operated in 300 block of East Countyline Road, Greenwood, Indiana.

As seen in the past, members of the Johnson County Sheriff's Office and the Franklin Police Department have completed a number of these type of investigations and we will continue to have them. Both Sheriff Duane Burgess and Chief Kirby Cochran of the Franklin Police Department have promised to work together in several different types of proactive crime prevention details.

We truly appreciate our inter-agency partnership with our local agencies. Together we are dedicated to protecting our youth and our community from these ruthless predators. We will continue to partner and work tirelessly to bring these folks to justice. The protection of our youth in our communities is paramount and our continued commitment to these operations will not waiver. We truly appreciate the hard work and dedication of our teams of dedicated Officers who work tirelessly to bring these perpetrators to justice said Chief Kirby Cochran.

During this particular detail or investigation Chief Doyme Little of the Edinburgh Police Department joined other investigators in making this a successful three day operation.

Johnson County Prosecutor Lance Hamner is also a very important part of this operation. He is consulted in the aspects of this investigation and certain Deputy Prosecutors are assigned to help investigators with any legal questions. One investigator from the Prosecutors Office is also assigned to assist.

"We are committed to protecting the children of our county by putting a stop to the sick and perverted practice of soliciting children for sex," said Prosecutor Hamner.

Johnson County is unique in that we have a great working relationship with our Prosecutors Office and other law enforcement agencies. Teamwork in crime fighting is essential to keeping our people safe.

Here are some stats for past Child Solicitation Stings conducted by the Johnson County Sheriff's Office and Franklin Police Department;

December of 2020 first Child Sex Sting, 10 arrests.

April of 2021, second Child Sex Sting, 8 arrests.

May of 2022, third Child Sex Sting 11 arrests.

November of 2022, fourth Sex Sting 20 arrests.

**April of 2023, fifth Sex Sting 32 arrests.**

81 Total Suspects have been arrested since beginning "Child Solicitation Stings"

Just last week the Brown County Sheriff's Office (Indiana) conducted their first Child Solicitation Sting. I applaud Sheriff Brad Stogsdill and his team in being proactive.

The Johnson County Sheriff's Office, Franklin Police Department, Edinburgh Police Department, and the Johnson County Prosecutors Office will continue to be proactive in all aspects of law enforcement. You will see us continue with the Child Solicitation Stings.

Protecting our children is our number one goal in Johnson County!

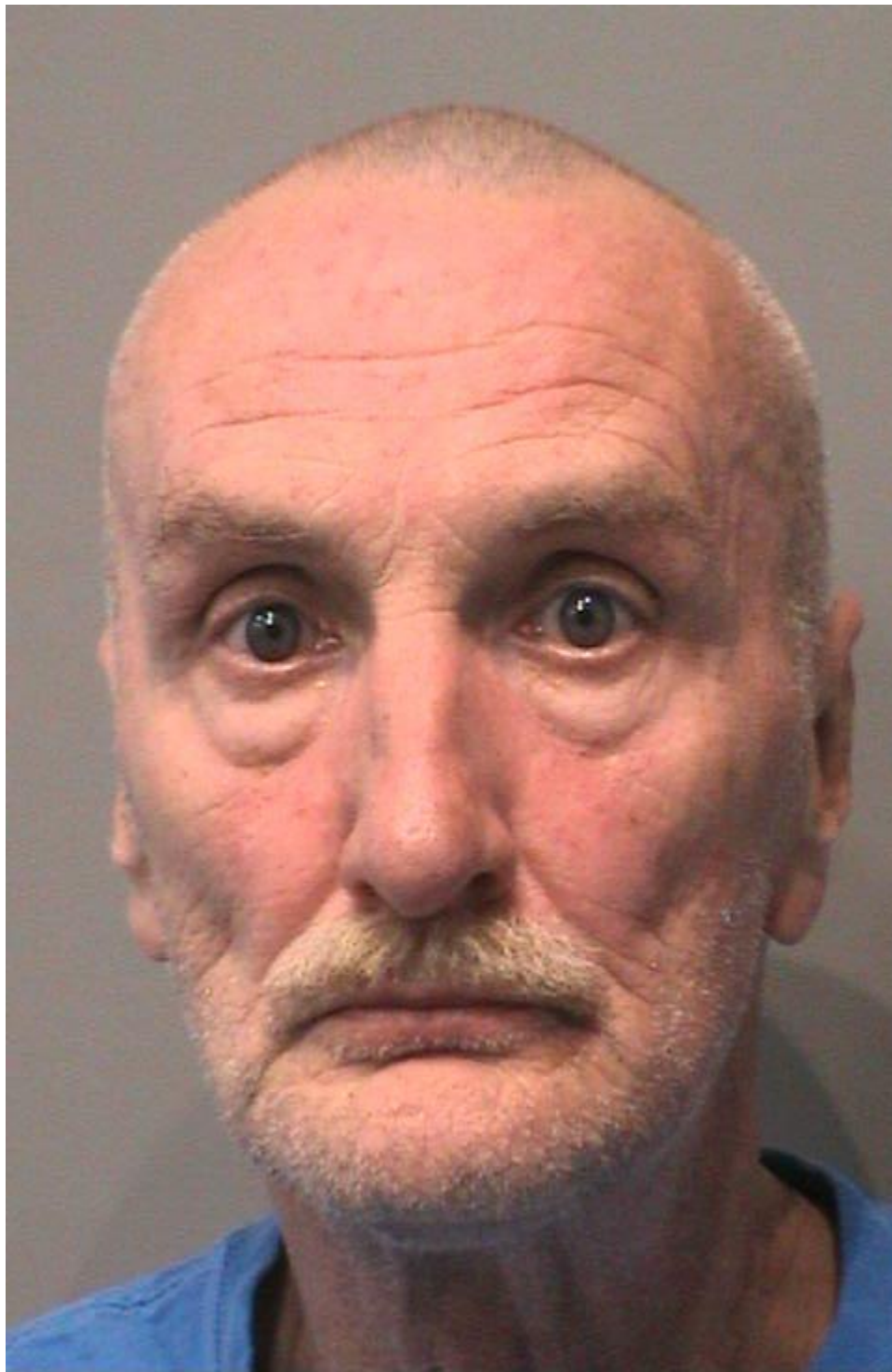
