**FIRST JOINT STIPULATIONS REGARDING EVIDENTIARY MATTERS**

Comes now the State of Indiana, by Deputy Prosecuting Attorney, Stacey L. Diener, the Defendant, Richard M. Allen, by Counsel, Bradley A. Rozzi, and the parties having reached an agreement regarding the admissibility of certain items of potential evidence and matters related to the separation of witness Order pertaining to the jury trial in this cause, the Court now finds and orders as follows:


1. The parties agree that the items referenced below shall be self-authenticated without the necessity of a witness verifying its origin, authenticity or chain of custody. The intention of this stipulation is to promote judicial economy throughout the course of the jury trial in this case. However, the parties do not agree to the specific admissibility or use of any item offered as evidence as each party reserves the right to argue such pursuant to the applicable Rules of Evidence;
2. All in-cell video recordings of Richard Allen while at Westville Correctional Facility or Wabash Valley Correctional Facility;
3. All video recordings of Richard Allen created through the use of a handheld camcorder utilized by the IDOC staff when Richard Allen was transported outside of his cell, unless said recordings include confidential communications between Richard Allen and his treating psychologists or psychiatrists;

4. All door sheet notes from inmate companions or Correctional Officers so long as said companion or Officer is called as a witness and testifies at the trial in this cause;
5. All medical and/or mental health records provided to the parties by the Indiana Department of Corrections or its agents, by way of discovery requests in this case, so long as the author of the mental health record and its contents is called as a witness at the trial in this cause;
6. Items collected at the crime scene where the victim's were located near the Monon High Bridge in Carroll County, IN;
7. Items collected pursuant to the search warrant of 1967 Whiteman Drive, Delphi, IN during the month of October 2022;
8. All AT&T records containing pings or other communications to and from any cellular towers in the area near the Monon High Bridge (Carroll County, Indiana) on February 13, 2017 or February 14, 2017;
9. All AT&T cell phone records for Liberty German's cell phone from February 13, 2017 and February 14, 2017;
10. The Chain of custody for Liberty German's phone;
11. The Chain of custody for the firearms tested by Melissa Oberg;
12. Electronic extractions done by Brian Bunner, including the extraction of Liberty German's phone which would include the video from the phone;
13. Electronic extractions done by Christopher Cecil, including all appendices and reports for said electronic devices;
14. Extraction of Derrick German's phone;

15. Hoosier Harvestore Video collected by the FBI with affidavit from FBI Special Agent Jeff Robertson with collection paperwork that was generated when the video was collected; and

16. Becky Patty, Mike Patty, Anna Williams, Kathy Allen, Janice Allen and Jamie Jones shall be excluded from the separation of witness order issued pursuant to Rule 615 of the Indiana Rules of Evidence, such that all of these individuals shall be permitted to attend the jury trial without being excluded as fact/rebuttal witnesses in this cause.


